

St Andrew's College Scholarship for Australian Indigenous Students

In 2022, St Andrew's College will offer up to four Indigenous Australian scholarships to support students who wish to study at the University of Sydney and who wish to reside in St Andrew's College.

1. The scholarship is awarded for up to three years to Australian Indigenous students:
 - Who will reside in St Andrew's College
 - Who will study at the University of Sydney
 - Who but for the scholarship will be unable to attend St Andrew's College.

2. The scholarship for 2022 will be in the amount of up to \$12,500 and paid as fee relief, half each semester unless the student is fully Abstudy eligible. In that case all fees may be covered by Abstudy and we will offer you a smaller scholarship to support with additional costs involving College.

3. Scholars will normally be expected to maintain a full time load and a satisfactory academic progress.

4. The scholarship is for Indigenous Australians. Applicants are required to provide confirmation that they are of Australian Aboriginal or Torres Strait Islander descent. This can be in the form of a letter of identity from your local land council or other official Aboriginal or Torres Strait Islander organisation, or statutory declaration. The Gadigal Centre also has applicants complete a "Proof of identity" confirmation.
